16.07.2015 (Thursday)	Member firms desiring to change their representatives shall intimate changes regarding name of representative to the Secretary General along with necessary proof of eligibility.
22.07.2015 (Wednesday)	Display of Provisional List of all members eligible to vote along with their National Tax No., Sales Tax Registration No., (if applicable) the name and National Identity Card No. of the Representative.

01.08.2015 (Saturday)	Last date for making representation to the Election Commission by any person aggrieved by the decision of the Secretary General
06.08.2015 (Thursday)	Last date for making decision by the Election Commission against the decision of the Secretary General.
08.08.2015 (Saturday)	Last date for filing of appeal to the Regulator, by any person aggrieved by the decision of the Election Commission, or in case the Election Commission fails, to decide within stipulated time.
15.08.2015 (Saturday)	Last date for taking decision by the Regulator on the appeals, if any.
19.08.2015 (Wednesday)	Display of Final List of voters at Notice Board and intimation to them by E-mail & website as well as submission to the Regulator.
	Provided that if no appeal has been filed to the Regulator, the final list of voters shall be displayed within Fifteen days of the decision of the Election Commission Under Sub Rule (6).
22.08.2015 (Saturday)	Last date for receipt of Nomination Papers from the members eligible to contest the election for the vacant post, duly proposed and seconded by a duly registered voter and signed by the candidate, to the Secretary General.
24.08.2015 (Monday)	i) Provision of a copy of the final list of voters to each contesting candidate. ii) Scrutiny of Nomination Papers by the Election Commission at 1100 hours in the Office of the Association and display of list of candidates.
26.08.2015 (Wednesday)	Last date for filing of objections, if any, to the nomination of candidates to the Election Commission.
31.08.2015 (Monday)	Last date for making decision by the Election Commission on the objections, if any, to the nomination of the candidates.

(Tuesday) Last date for filing of appeal to the Regulator by any candidate aggrieved by the decision of the Election Commission or in case Commission fails, to decide within the stipulated time.
- 05.09.2015**
(Saturday) Last date for taking decision by Regulator against an appeal filed by an aggrieved candidate.
- 10.09.2015**
(Thursday) Withdrawal of nomination papers.
- 11.09.2015**
(Friday) Issuance of final list of candidates by the Commission within two days of the decision of the Regulator on appeals.
