Last date for making representation to the Election Commission by any person aggrieved by the decision of the Secretary General

Last date for making decision by the Election Commission against the decision of the Secretary General.

12.08. 2026
(Wednesday)

Last date for filing of appeal to the Regulator, by any person aggrieved by the decision of the Election Commission, or in case the Election Commission fails, to decide within stipulated time.

21.08. 2026
(Friday)

Last date for taking decision by the Regulator on the appeals, if any.

22.08. 2026
(Saturday)

Display of Final List of voters at Notice Board and intimation to them by E-mail & website as well as submission to the Regulator. Provided that if no appeal has been filed to the Regulator, the final list of voters shall be displayed within Fifteen days of the decision of the Election Commission Under Sub Rule (6).

27.08. 2026
(Thursday)

last date for receipt of Nomination Papers from the members eligible to contest the election for the vacant post, duly proposed and seconded by a duly registered voter and signed by the Candidate, to the Secretary General.

28.08. 2026
(Friday)

- i) Provision of a copy of the final list of voters to each contesting candidate.

Issuance of final list of candidates by the Commission within two days of the decision of the Regulator on appeals.

-Provided that if no appeal has been filed to the Regulator, the final list of candidates shall be issued within 11 days of the decision of the Election Commission under -Sub Rule (12) of Trade Organization Rules 2013.
